



Healthwatch Tameside Impact & Operational Report - May Board 2025

Operational team updates

Annual report – Progression has been made against the 24/25 Healthwatch Tameside annual report. The Coordinator will lead on the production of the report, planning sessions with the Manager have taken place to map out our approach and content. Tameside Enhanced Multi-Professional Learning Experience (TEMPLE) – From June 2025, we will welcome allied health care students, studying at University in Manchester the opportunity to gain experience alongside our Healthwatch Tameside team. We will welcome, one student every 2-weeks for one-day, 10 am – 3pm. The aim of this programme, in partnership with GM Integrated Care Partnership is to introduce students to support available in the community they are set to graduate in; upskilling and informing future health professionals.

Healthwatch Stockport run a similar programme and have reported a very positive experience, benefitting the students and the HW team. The students will take part in desk-top activities in the morning, followed by an outreach opportunity in the afternoon (poised as a Tuesday/Wednesday).

Working with people - Signposting case study example:

Whilst completing an engagement session with the Sight Loss Group as part of our Accessible Information Standard Project. Outreach Officer, Karen was presented with a question from a group member who asked if she knew of any support available, to help the group with the cost of room hire as these had recently increased. Karen connected the group members with Jon, the Action Together Community Development Worker in Stalybridge who has since contacted the group member and has provided detail of current and upcoming funding opportunities, to help the group cover the increasing costs. Pharmacy First

The report was scheduled to be sent to the board following the March meeting. We have since utilised a peer support function, provided by Healthwatch England; that provides feedback to local Healthwatch teams on reports, ultimately with an aim of increasing impact such workstreams can achieve.
